Ways to Give a Legacy Gift

THERE ARE SEVERAL WAYS TO GIVE A LEGACY GIFT TO THE ANIMAL HAVEN. YOU CAN:

- make a bequest to The Animal Haven in your will or trust. To do this, you will need our legal name: The Animal Haven, Inc., and our EIN 06-0735382
- transfer a bank or investment account to The Animal Haven by using the “payable on death” or “transfer on death” designation
- make The Animal Haven a beneficiary of your retirement account; there are financial benefits to doing this that you should discuss with your attorney and/or financial advisor
- name The Animal Haven as a beneficiary of a life insurance policy
- establish a charitable gift annuity through The Community Foundation for Greater New Haven (or other foundation), naming The Animal Haven as a beneficiary
- set up an individually-named designated fund at The Community Foundation for Greater New Haven (or other foundation) to provide an annual revenue stream to The Animal Haven in perpetuity
